Job description

Information and communications technology managers plan, organise and direct the IT systems in organisations. Working at the cutting-edge of innovation using the latest technologies, they improve systems and workflows and solve IT problems.

What ICT managers do

ICT managers ensure a company's IT infrastructure is fit for purpose. This includes providing staff with the machines and software they need, ensuring network connections function effectively and that the business has a suitable IT strategy to meet its demands.

ICT managers are involved in high-level decision-making. They're responsible for the implementation of technology systems and directing the work of systems and business analysts, developers and support specialists.

In a single day, an ICT manager can work on recruiting, budgeting, planning, coding and design reviews. They liaise with senior members of staff, hire and train new employees, strategise and plan new IT projects, and work with colleagues to troubleshoot IT problems.

While an ICT manager doesn't get involved in the nitty-gritty of a project, they combine their technical, communication and management skills to oversee and advise on the successful completion of projects as well as the day-to-day running of their department.

- direct the selection and installation of ICT resources and the provision of user training
- direct ICT operations
- set priorities between system developments, maintenance and operations
- oversee the security of ICT systems.
